

**A REGULAR MEETING

1. A Regular Meeting was called to order by Acting Chair Conaway in the Hearing Room, 861 Silver Lake Boulevard, Dover, Delaware, on Tuesday, January 20, 2015, at 1:02 p.m. with the following Commissioners in attendance: Jeffrey Clark, Harold Gray and Jaymes Lester.
