

to the Commission in which Delmarva would propose changes to the balancing fees associated with the GCR;² and

WHEREAS, on February 3, 2015, pursuant to 26 *Del. C.* §§201 and 301 and Order Nos. 8578 (July 8, 2013), 8649 (September 30, 2014), and 8701 (January 6, 2015) in PSC Docket No. 13-349F, Delmarva filed an application ("Application") requesting Commission approval to implement a new balancing fee structure consisting of two separate components: (1) a new Balancing Fee ("Balancing Fee") of \$0.5530 per Mcf for 2015-2016, which is designed to recover swing and storage service costs attributable to customers in service classifications Firm Transportation ("FT"), Interruptible Transportation ("IT"), Large Volume Gas - Qualifying Fuel Cell Provider-Renewable Capable ("LVG-QFCP-RC"), and certain contract customers and which will be assessed on the differences (under- and over-deliveries) between gas delivered to the Company's gate stations and the amount of gas actually used by the customer; and (2) a Pressure Support Fee ("PSF") of \$0.1893 per Mcf for 2015-2016, which is designed to recover the costs of Eastern Shore Natural Gas Company capacity from Sales (GCR), FT and LVG-QFCP-RC customers that benefit from pressure support, and which the Company proposes to allocate among such customers using throughput as the determinant; and

WHEREAS, Delmarva proposes that the Commission schedule public workshops for interested stakeholders so that Delmarva can

further analyze and potentially refine the proposed balancing fee structure;

**NOW, THEREFORE, IT IS ORDERED BY THE AFFIRMATIVE VOTE OF
NOT FEWER THAN THREE COMMISSIONERS:**

1. Under 26 *Del. C.* §§201, 301, 304 and 305, and pursuant to Order No. 8430 (August 13, 2013) in PSC Docket No. 13-349F, the Commission has the authority to review, investigate, and approve or reject Delmarva's proposed changes to its current methodology for calculating balancing fees associated with the GCR as set forth in the Application.

2. Delmarva's proposed changes to the Balancing Fee and PSF as set forth in the Application are hereby suspended pursuant to 26 *Del. C.* §306(a)(1) pending further Order of the Commission.

3. Mark Lawrence is hereby designated as the Hearing Examiner for this docket pursuant to 26 *Del. C.* §502 and 29 *Del. C.* ch. 101. Hearing Examiner Lawrence shall schedule and conduct such public evidentiary hearings as may be necessary or appropriate to develop a full and complete record concerning this matter. Hearing Examiner Lawrence shall thereafter prepare and submit to the Commission a proposed order for the Commission's consideration, the proposed order shall include a brief summary of the evidence and recommended findings of fact based upon the evidence presented, his recommended conclusions of law, and his recommended decision. Pursuant to 26 *Del. Admin. C.* §1001-2.9.3, Hearing Examiner Lawrence is delegated the authority to grant or deny petitions to intervene. In addition, Hearing Examiner Lawrence is delegated the authority under 26 *Del. C.* §102A to

determine the content, form, and manner of any further notice in this matter and is delegated the authority under 26 *Del. Admin. C.* §1001-2.1.2 to grant applications of counsel for admission pro hac vice.

4. Delmarva shall cause to be published in The News Journal newspaper, in two-column format outlined in black, a copy of the form of notice attached hereto as Exhibit "A". Such notice shall be published **on or before March 18, 2015**. Delmarva shall file proof of such publication with the Commission as soon as practicable, but no later than **April 20, 2015**. In addition, Delmarva shall cause a copy of the attached notice to be sent via electronic mail to each Firm Transportation and LVG-QFCP-RC Customer. Delmarva shall thereafter file with the Commission, no later than April 20, 2015, a certification that such notice was sent, listing the names of the Firm Transportation and LVG-QFCO-RC Customers receiving such notice.

5. The Commission's Secretary shall promptly serve a copy of this Order on the DPA.

6. Interested persons may file comments, suggestions, and objections to Delmarva's proposed changes **on or before April 30, 2015**.

7. The deadline for filing petitions for leave to intervene pursuant to 26 *Del. Admin. C.* §1001-2.9 of the Commission's Rules of Practice and Procedure and for filing written comments, suggestions, and objections, **is April 20, 2015**. Late-filed petitions to intervene will not be granted unless good

cause is shown. Pursuant to Rule 1000.6.4 of the Commission's Rules of Practice and Procedure, 26 *Del. Admin. C.* §1000.1.6.4, petitions for intervention should be filed using the DelaFile e-filing system, which can be accessed from the Commission's website at <http://depsc.delaware.gov>.

8. Delmarva is hereby placed on notice that the costs of the proceedings will be charged to it under the provisions of 26 *Del. C.* §114(b)(1).

9. That the Commission reserves the jurisdiction and authority to enter such further Orders in this matter as may be deemed necessary or proper.
