**ORDER NO. 8648**

**AND NOW**, this 30<sup>th</sup> day of September, 2014, the Delaware Public Service Commission ("Commission") determines and orders the following:

**WHEREAS**, on September 2, 2014, Chesapeake Utilities Corporation ("Chesapeake" or "the Company") filed with the Commission the above-captioned application (the "Application") seeking approval to change its Gas Sales Service Rates ("GSR") effective for usage on or after November 1, 2014, as follows: (1) decrease the Company's current GSR rate from \$1.132 per Ccf to \$1.069 per Ccf for customers served under rate schedules RS-1, RS-2, GS, MVS and LVS; (2) decrease the Company's current GSR rate from \$0.656 per Ccf to \$0.552 per Ccf for customers served under rate schedules GLR and GLO; (3) decrease the Company's current GSR rate from \$0.941 per Ccf to \$0.849 per Ccf for customers served under rate schedule HLFS; (4) decrease the Company's firm balancing rate for transportation customers served under rate schedule LVS from \$0.072 per Ccf to \$0.058 per Ccf; (5) decrease the Company's firm balancing rate for transportation customers served under rate schedule HLFS from \$0.015 per Ccf to \$0.012 per Ccf; and (6) maintain the Company's interruptible balancing rate for transportation customers served under rate schedule ITS at \$0.001 per Ccf; and

**WHEREAS**, the Commission has determined, pursuant to 26 Del. C.

§§304 and 306, that the proposed GSR changes should be permitted to become effective for usage on and after November 1, 2014, subject to refund and pending the Commission's further review and final decision;

**NOW, THEREFORE, IT IS HEREBY ORDERED BY THE AFFIRMATIVE VOTE OF NOT FEWER THAN THREE COMMISSIONERS:**

1. Pursuant to 26 Del. C. §§303(b), 304, and 306, the following proposed changes to the GSR rates, firm balancing rates, and interruptible balancing rate of Chesapeake, and the accompanying proposed tariff revisions set forth in the Application, are permitted to become effective for natural gas usage on or after November 1, 2014, subject to refund and pending the Commission's final decision:

2. R. Campbell Hay is designated as the Hearing Examiner for this docket pursuant to 26 Del. C. §502 and 29 Del. C. ch. 101. Hearing Examiner Hay shall schedule and conduct such public evidentiary hearings as may be necessary or appropriate to develop a full and complete record concerning this matter. Hearing Examiner Hay shall thereafter prepare and submit to the Commission a proposed order for the Commission's consideration, which proposed order shall include a brief summary of the evidence and recommended findings of fact based

upon the evidence presented, his recommended conclusions of law, and his recommended decision. Pursuant to 26 Del. Admin. C. §1001-2.9.3, Hearing Examiner Hay is delegated the authority to grant or deny petitions to intervene. In addition, Hearing Examiner Hay is delegated the authority under 26 Del. C. §102A to determine the content, form, and manner of any further notice in this matter and is delegated the authority under 26 Del. Admin. C. §1001-2.1 to grant applications of counsel for admission *pro hac vice*.

3. Chesapeake shall give public notice of the filing of this Application, with the proposed rate changes and this action by the Commission, by publishing notice in the form attached as **Exhibit "A"** in two-column format, outlined in black, in the legal classified section of The News Journal newspaper on **Tuesday, October 7, 2014**, and the Delaware State News newspaper on **Wednesday, October 8, 2014**. Chesapeake shall submit proof of such publications as soon as possible, but no later than the commencement of any evidentiary hearings concerning this matter.

4. The deadline for intervention pursuant to 26 Del. Admin. C. §1001-2.9 shall be **October 29, 2014**. Petitions for intervention that are not received by the Commission **on or before October 29, 2014**, will not be granted unless good cause is shown. Pursuant to Rule 1000.6.4 of the Commission's Rules of Practice and Procedure, 26 Del. Admin. Code §1000.1.6.4, petitions for intervention should be filed using the Delafile e-filing system, which can be accessed from the Commission's website at <http://depsc.delaware.gov>.

5. Chesapeake is hereby put on notice that it will be charged

the costs incurred by the Commission staff and the Division of the Public Advocate in connection with this proceeding under the provisions of 26 Del. C. §114(b)(1).

6. The Commission reserves the jurisdiction and authority to enter such further Orders in this matter as may be deemed necessary or proper.

**Chesapeake Utilities Corporation's Gas Sales Service Rates Application**

Pursuant to 26 Del. C. §§303(b), 304, and 306, Chesapeake Utilities Corporation ("Chesapeake" or "the Company") has filed an application (the "Application") with the Delaware Public Service Commission (the "Commission") seeking to change its Gas Sales Service ("GSR") Rates as follows:

Rate Schedule	Present Rate	Proposed Rate
RS-1, RS-2, GS, MVS, LVS	\$1.132 per Ccf	\$1.069 per Ccf
GLR, GLO	\$0.656 per Ccf	\$0.552 per Ccf
HLFS	\$0.941 per Ccf	\$0.849 per Ccf

Compared to the rates currently in effect, an average RS-2 customer using 700 Ccf per year will experience an annual decrease of approximately 3.8%, or \$3.67 per month. During the winter heating season, a typical RS-2 customer using 110 Ccf per winter month will experience an decrease of approximately 4.2%, or \$6.93 per winter month.

The Company has also proposed the following changes to its firm and interruptible transportation balancing rates:

The Commission has permitted the proposed GSR and other rates to become effective with usage on and after November 1, 2014, subject to refund and pending the Commission's final decision after evidentiary hearings and any other proceedings that may be necessary.

The Commission will conduct evidentiary hearings, to be scheduled at a later date, concerning this Application. The Commission's final decision will be based on the evidence presented at such hearings.

If you wish to formally participate as a party in this matter, with the right to present evidence and be represented by counsel, you must file with the Commission a written petition asking for leave to intervene in accordance with the requirements of the Commission's

Rules of Practice and Procedure (26 Del. Admin. C. §1001-2.9) **on or before October 29, 2014.** All such petitions should be e-filed according to the Commission's Rules (26 Del. Admin. C. §1001-1.6.4). Petitions filed after the deadline of October 29, 2014, will not be considered except for good cause shown.
