AND NOW, to-wit, this 9th day of May, 2006,

WHEREAS, on May 5, 2006, UGI Energy Services, Inc., d/b/a GASMARK ("UGI" or "Company"), a Certified Electric Supplier in the State of Delaware, filed an application with the Delaware Public Service Commission (the "Commission") seeking a waiver to include certain language regarding the termination of a customer contract when a customer relocates outside of the Electric Distribution Company's ("EDC") service territory in accordance with the Rules for the Certification and Regulation of Electric Suppliers that was adopted by the Commission in PSC Regulation Docket No. 49, Order No. 5207 (Aug. 31, 1999); and

WHEREAS, UGI proposes modifying of PSC Regulation No. 49, Section II, 1(i)(7) by adding the following language:

"Upon receiving notice of termination, UGI will proceed to sell, liquidate or cash-out in a commercially reasonable manner the additional quantities of power purchased for Customer's account for the remaining term of the Contract. Any loss on such liquidation shall be charged to Customer, and any gain on such liquidation shall be credited to Customer."

WHEREAS, Staff supports the proposed amendment with certain conditions; now, therefore,

IT IS HEREBY ORDERED:

1. The Commission approves UGI Energy Services, Inc.'s, d/b/a GASMARK, proposed amendment of PSC Regulation No. 49, Section II, 1(i),(7) until such time as the proposed modifications to Regulation No. 49 are approved by this Commission.

2. The proposed UGI Energy Services, Inc.'s, d/b/a GASMARK, amendment shall only apply to customers taking service in rate classes MGS (Medium General Service) and higher.

3. The proposed amendment shall include language to alert prospective customers that UGI Energy Services, Inc., d/b/a GASMARK, may request termination fees for customers who leave its supply service.

4. The Commission reserves the jurisdiction and authority to enter such other or further Orders in this matter as may be deemed necessary or proper.
