**ORDER NO. 7311**

**AND NOW**, to-wit, this 6<sup>th</sup> day of November, 2007;

**WHEREAS**, Sussex Shores Water Company ("Sussex Shores" or "the Company"), having, on October 15, 2007, filed with the Public Service Commission ("the Commission") an application with proposed revised tariffs designed to produce an annual increase of approximately 22.7% in the Company's revenues or approximately \$305,873 in additional revenues; and

**WHEREAS**, the Commission having determined that pursuant to the authority granted to the Commission by 26 Del. C. § 306(a)(1), the filing by Sussex Shores shall be suspended pending full and complete evidentiary hearings into the justness and reasonableness of the proposed new rates; now, therefore,

**IT IS ORDERED:**

1. That the rates and associated tariff changes filed by Sussex Shores Water Company with the Delaware Public Service Commission on October 15, 2007, are hereby suspended pursuant to 26 Del. C. § 306(a)(1) and shall not be placed into force or effect except pursuant to further Order of the Commission or pursuant to law, and then only to the extent such further Commission Order or such law may permit or allow.

2. That, pursuant to the requirements of 26 Del. C. §§ 102A and 304, Sussex Shores Water Company shall give public notice of the application for increased rates by causing the publication of the notice attached hereto as Exhibit "A" in The Wave and Delaware State News newspapers, in two-column format, outlined in black, on the following dates:

Wednesday, November 14, 2007 (The Wave)

Thursday, November 15, 2007 (Delaware State News).

Proof of such publication shall be filed with the Commission as soon thereafter as is reasonably practicable but prior to the date set for any evidentiary hearing in this docket.

3. That Gary A. Myers is designated as Hearing Examiner for this matter pursuant to the terms of 26 Del. C. § 502 and 29 Del. C. ch. 101 to schedule and conduct such evidentiary hearings as may be necessary to have a full and complete evidentiary record concerning the justness and reasonableness of the proposed increased rates and to thereafter file a report and recommendations with the Commission. Dates and times for serving and responding to discovery shall be included in the procedural schedule. Hearing Examiner Myers is specifically delegated the authority to grant or deny petitions seeking leave to intervene. In addition, Hearing Examiner Myers is delegated the authority, under 26 Del. C. § 102A, to determine the form and manner of any further public notice concerning this docket. Francis J. Murphy, Esquire, is designated Rate Counsel for this matter.

4. That the Applicant is hereby placed on notice that the cost of the proceeding will be charged to it under the provisions of 26 Del. C. § 114(b)(1).

5. That the Commission reserves the jurisdiction and authority to enter such other or further Orders in this matter as may be deemed necessary or proper.

**TO: ALL CUSTOMERS OF SUSSEX SHORES WATER COMPANY,  
AND OTHER INTERESTED PERSONS**

On October 15, 2007, Sussex Shores Water Company ("Sussex Shores" or "the Company") filed with the Delaware Public Service Commission ("the Commission") an application for an increase in its water service rates. The new proposed rates and charges are designed to produce additional annual revenues to the Company of approximately \$305,873. This is a proposed increase in annual revenue of approximately 22.7%. An average customer with a 3/4" water meter using 11,576 gallons of water per quarter would see their quarterly bill increase from \$137.70 to \$164.48, or by \$26.78, if the full increase is authorized.

The following is a comparison of Sussex Shores' present rates and those proposed in the application:

Pursuant to 26 Del. C. § 306(a)(1), the Commission has suspended the effectiveness of the proposed new rates and the proposed rule revisions pending further investigation and public evidentiary hearings, which will be held at a later date after further public notice. However, the utility is expected to exercise its right under 26 Del. C. § 306(c) and place a portion of the proposed rate increase into effect under bond and subject to refund sixty (60) days after the October 15, 2007 filing date.

The Commission will make its decision on this matter on the basis of the evidence of record taken at the public evidentiary hearings. The

Commission may approve or reject, in whole or in part, the proposed increase and revisions and may approve a different method for allocating among rates any allowed increase in revenues should one be found to be appropriate.

Any person wishing to participate as a party in this docket (PSC Docket No. 07-278) should file for leave to intervene with the Commission in accordance with Rule 11 of the Commission Rules of Practice and Procedure.
