AND NOW, this 2nd day of December, 2008;

WHEREAS, the Town of Smyrna ("the Town"), Delaware, which owns and operates a municipal electric distribution system for the purpose of distributing and reselling electricity within its duly authorized electric service territory, has notified the Commission of the annexation of three parcels of land previously adjacent to the boundaries of the Town; and

WHEREAS, upon notification of such annexations, the Commission is required, by the provisions of 26 Del. C. § 203B(a), to revise the

official electric service territory maps to reflect such annexations;
now, therefore,

IT IS ORDERED:

1. That the official maps of the Commission which depict the existing electric service territories for all electric utilities within the State of Delaware shall be appropriately revised and modified to show the annexations by the Town of Smyrna of the following two Kent County Tax Map Parcels Nos.: DC-00-009.20-01-09.00-000 and DC-00.018-08.02-16.00-000; and New Castle County Tax Map Parcel No. 15-22.00-092; which are described in more detail in the correspondence and exhibits submitted by the Town of Smyrna in its applications.

2. That the Secretary of the Commission shall provide a copy of this Order to each retail electric supplier for which the Commission has established a retail electric service territory.

3. That the Commission reserves the jurisdiction and authority to enter such further Orders in this matter as may be deemed necessary or proper.
