**ORDER NO. 7570**

**AND NOW**, to-wit, this 19<sup>th</sup> day of May, 2009;

**WHEREAS**, the Commission having, on May 19, 2009, conducted a public evidentiary hearing on the application filed by Comcast of Eastern Shore, LLC ("Comcast"), seeking approval to make changes in the maximum permitted rates for basic cable television service and equipment and installation charges governing service provided by Comcast in the unincorporated areas of southeast Sussex County served by the Ocean City, Maryland head-end and designated as Community Unit Identifier ("CUID"), DE0023; and

**WHEREAS**, based on the evidence so presented, the Commission having determined that Comcast's proposed rate adjustments, as they appear on its Federal Communications Commission ("FCC") Forms 1240 and 1205, have been calculated in accordance with the regulations of the FCC and, hence, should be approved for service effective June 1, 2009.

**NOW, THEREFORE, IT IS HEREBY ORDERED BY THE AFFIRMATIVE VOTE OF NOT FEWER THAN THREE COMMISSIONERS:**

1. That the Commission approves the maximum permitted rates for basic cable service and equipment and installation as set forth below for

service offered by Comcast of Eastern Shore, LLC, in the unincorporated areas of Sussex County served by the Ocean City, Maryland head-end and designated as CUID DE0023, with such maximum permitted rates to be effective for service after June 1, 2009.
