ORDER NO. 7594

AND NOW, this 7th day of July, 2009;

WHEREAS, the Town of Smyrna ("the Town"), Delaware, which owns and operates a municipal electric distribution system for the purpose of distributing and reselling electricity within its duly authorized electric service territory, notified the Delaware Public Service Commission (the "Commission"), by letter dated April 6, 2009, of the annexation (the "Annexation") of two parcels of land on the Town boundary line, which were recently incorporated into the Town limits (New Castle County Tax Map Parcels Nos. 15-027.00-021 and 15-027.00-021M0001) (hereafter, the "Annexed Parcels"); and

WHEREAS, with its letter the Town submitted deeds for the Annexed Parcels, maps, and the Town Ordinance effecting the Annexation; and

WHEREAS, the Annexed Parcels were in the electric service territory of Delmarva Power & Light Company ("DP&L" or the "Company"); and

WHEREAS, under 26 Del. C. § 203B(a), upon being notified of such annexations, the Commission is required to revise the official electric service territory maps to reflect such annexations; and

WHEREAS, the Commission Engineering Staff has reviewed the documentation submitted with the Town's letter and has discussed the Annexation with DP&L; and

WHEREAS, the Commission Engineering Staff recommends that the Commission's official electric service territory maps be revised to reflect the Annexation;

NOW, THEREFORE, IT IS HEREBY ORDERED BY THE AFFIRMATIVE VOTE OF NOT FEWER THAN THREE COMMISSIONERS:

1. That the official maps of the Commission depicting the existing electric service territories for all electric utilities within the State of Delaware shall be appropriately revised and modified to show the annexation by the Town of Smyrna of New Castle County Tax Map Parcels Nos. 15-027.00-021 and 15-027.00-021M0001, as more particularly described in the correspondence and exhibits submitted by the Town of Smyrna with its letter dated April 6, 2009.

2. That the Secretary of the Commission shall provide a copy of this Order to each retail electric supplier for which the Commission has established a retail electric service territory.

3. That the Commission reserves the jurisdiction and authority to enter such further Orders in this matter as may be deemed necessary or proper.
