Pursuant to the environmental remediation recovery mechanism approved in PSC Order No. 4104 (December 19, 1995) in PSC Docket No. 95-73, Chesapeake Utilities Corporation ("Chesapeake") has filed an application (the "Application") with the Commission proposing an increase in the Environmental Rider ("ER") from a surcharge of \$0.0000 per Ccf to \$0.0001 per Ccf for all firm delivery customers. The increased rate will become effective with usage on and after December 1, 2015, with proration, subject to modification and refund after an evidentiary hearing.

For a typical residential heating customer using 120 Ccf of gas per month, the effect of the proposed ER rate change will be an increase in the monthly bill of approximately \$0.01, or a 0.01% increase in their total bill.

By **Order No. 8817** dated November 24, 2015, the Commission approved the proposed rates to become effective with usage on and after December 1, 2015, with proration, subject to modification and refund after an evidentiary hearing.
