

**PETITION FOR LEAVE TO  
INTERVENE OF  
DELMARVA POWER & LIGHT COMPANY**

Delmarva Power & Light Company (“Delmarva”), by and through its undersigned counsel, and pursuant to 26 *Del. Admin. C.* 1001 §2.9, respectfully petitions for leave to intervene as a party in the above-captioned proceeding.

In support of its Petition, Delmarva states as follows:

1. Delmarva is a public utility regulated by the Delaware Public Service Commission (“Commission”); it provides gas and electric service to customers in Delaware, and has its principal place of business in Newark, Delaware.
2. On January 21, 2016, The Retail Energy Supply Association (“RESA”) filed a petition with the Commission requesting that the Commission order Delmarva to implement a Purchase of Receivables (“POR”) program, on an expedited basis.
3. The proceeding has been designated PSC Docket No. 16-0112.
4. The implementation of a POR program would directly impact Delmarva and its electric customers; therefore, Delmarva has a unique interest in this docket.
5. None of the other parties who have intervened or who are likely to intervene in this proceeding have interests that are identical to the unique interests of Delmarva. Delmarva’s

interests in this proceeding will not be adequately represented without being granted intervenor status. Moreover, the public interest will be served by Delmarva's participation as a party to this proceeding.
