Dear Ms. Hall:

This letter concerns Delmarva's Integrated Resource Plan ("IRP"), which was filed in both a "Public" version and a "Sealed" version under Commission Rule 11. The material Delmarva redacted from the Sealed IRP appears on page 102 and relates to Delmarva's estimates of what rates customers will pay in 2013/14 and 2015/16 as a result of an ongoing auction and Commission review process (referred to jointly as the "Confidential IRP Material").

During the Commission's March 5, 2013 regularly scheduled meeting, the Commission's Technical Consultant for the Standard Offer Service (SOS) procurement process issued its report on the results of the SOS auctions (the "Report"). The Report was released as a publicly available document and, as planned, revealed the results of the SOS auctions. As such, the reason for maintaining confidentiality over the material on page 102 of the IRP no longer exists.

Delmarva hereby requests: (1) that the "sealed" IRP be destroyed and (2) that the enclosed version of the Sealed IRP and previously sealed section of the Appendix be filed and made publicly available in its place. The enclosed version of the IRP and appendix sections is identical to the formerly "Sealed" versions with the following designation added: "~~CONFIDENTIAL/ SEALED VERSION~~ (UNSEALED BY DPL REQUEST 3/8/13)." We believe that replacing the former "Sealed" documents with this appropriately labeled identical version will avoid future confusion among the parties, Staff, DPA, interveners and others regarding the various versions.
