AND NOW, to-wit, this 25th day of October, A.D. 2005;

WHEREAS, the Commission having, on October 25, 2005, conducted a public evidentiary hearing on the applications filed by Comcast of Delmarva, Inc. ("Comcast"), seeking approval to make changes in the maximum permitted rates for basic cable television service and equipment and installation charges governing service provided by Comcast in the areas designated as Community Identifier Units DE0034, DE0059, DE0062, DE0070, DE0074, DE0079, DE0088, DE0091, and DE0093; and

WHEREAS, based on the evidence so presented, the Commission having determined that Comcast's proposed rate adjustments as they appear on its amended FCC Forms 1240 and 1205, have been calculated in accordance with the Rules and Regulations of the Federal Communications Commission and, hence, should be approved for service after November 1, 2005; now, therefore,

IT IS ORDERED:

1. That the Commission hereby approves the maximum permitted rates for basic cable service and equipment and installation as set forth below for service offered by Comcast of Delmarva, Inc., in the areas designated as Community Identifier Units DE0034, DE0059, DE0062, DE0070, DE0074, DE0079, DE0088, DE0091, and DE0093, with such maximum permitted rates to be effective for service on and after November 1, 2005.
