### ORDER NO. 8013

AND NOW, this 23<sup>rd</sup> day of August, 2011:

WHEREAS, on April 27, 2011, Gull Point Condominium Association<sup>1</sup> ("Gull Point" or the "Company") filed an application (the "Application") with the Delaware Public Service Commission (the "Commission") requesting approval of a decrease in its rate for wastewater service from \$560.00 per year to \$529.00 per year;<sup>2</sup> and

WHEREAS, on May 24, 2011, in PSC Order No. 7972, the Commission suspended the proposed rate change in accordance with 26 *Del. C.* §306(a) (1) and ordered that a hearing on the Application be held at its regular meeting on Tuesday, July 26, 2011, to determine the justness and reasonableness of the proposed decreased rate or to consider whether the matter should be referred to a hearing examiner for further proceedings; and

WHEREAS, on May 27, 2011, Gull Point provided the Commission with written notice<sup>3</sup> that it complied with the mailing requirements set

forth in PSC Order No. 7972, Paragraph No. 2, regarding the deadline for intervention and written comments; and

WHEREAS, the intervention period expired on July 1, 2011, and no party filed to intervene in this action or filed any written comments regarding this matter; and

WHEREAS, on July 26, 2011, at the request of Commission Staff ("Staff") the Commission extended the hearing deadline for this matter to August 23, 2011, at 1:00 p.m. (see PSC Order No. 8006) to determine the justness and reasonableness of the proposed decreased rate or to consider whether the matter should be referred to a hearing examiner for further proceedings; and

WHEREAS, Gull Point was ordered to file an application with the Commission for the issuance of a Certificate of Public Convenience and Necessity as soon as practicable, but no later than July 31, 2011; and

WHEREAS, because Gull Point needed additional time to prepare and file its application for the issuance of a Certificate of Public Convenience and Necessity, the Commission ordered that Gull Point file an application with the Commission for the issuance of a Certificate of Public Convenience and Necessity as soon as practicable, but no later than September 20, 2011 (see PSC Order No. 8006); and

WHEREAS, at the August 23, 2011 evidentiary hearing, Staff witness Heidi Wagner testified that Staff investigated Gull Point's financial and cost data, as outlined in her July 29, 2011 memorandum to the Commission,<sup>4</sup> and determined that the proposed reduced rate of \$529 per year fully covers the Company's projected operating costs and

sustains an adequate reserve fund through 2024 and, based thereon, concluded that the proposed rate is just and reasonable and should be approved;

# NOW, THEREFORE, IT IS HEREBY ORDERED BY THE AFFIRMATIVE VOTE OF NOT FEWER THAN THREE COMMISSIONERS:

1. The Application filed on April 27, 2011, by the Association of Owners of Gull Point Condominium, Inc. for approval of a decrease in its rate for wastewater service from \$560.00 per year to \$529.00 per year is hereby approved as just and reasonable.

2. That the Secretary shall promptly serve a copy of this Order on the Division of the Public Advocate.

3. That the Commission's previous order (PSC Order No. 8006) requiring the Association of Owners of Gull Point Condominium, Inc. to file an application with the Commission for the issuance of a Certificate of Public Convenience and Necessity as soon as practicable, but no later than **September 20**, **2011**, shall remain in effect.

4. That the Commission reserves the jurisdiction and authority to enter such further Orders in this matter as may be deemed necessary or proper.

### Request for Approval of A Decrease in Wastewater Rates for Gull Point

### Application:

By letter dated April 25, 2011, The Association of Owners of Gull Point Condominium, Inc. ("Gull Point" or "Association") requested that the Delaware Public Service Commission ("Commission") approve a decrease in the rate for wastewater service to the development known as Gull Point, located in Sussex County. By Commission Order No. 7201 dated June 19, 2007, Gull Point was granted a Temporary Operating Certificate to provide service to Gull Point. Staff notes that prior to July 6, 2004, Gull Point's wastewater system was owned and operated by Utility Systems, Inc. ("USI"). The Commission revoked USI's CPCN and Gull Point was then granted the Temporary Operating Certificate. Gull Point will be filing an application for the issuance of a CPCN as soon as practicable, but no later than September 20, 2011.

The wastewater facility is operated by White Marsh Environmental Systems, Inc. and has 166 connections. There are no plans to have additional residential or commercial connections. The existing approved annual rate is \$560. Gull Point is requesting a rate reduction of \$31 annually. In part, this reduction is based on a Reserve Study completed by Criterium-Harbor Engineers (the "Reserve Study") for Gull Point in 2010, as well as a review of the actual wastewater operating expenses of Gull Point over the past few years. The chart below shows sufficient distributions to cover expenses and distributions to the Reserve Account.

### Staff's Review:

Staff has reviewed the General Ledger for calendar year 2010, Budgets for 2010 and 2011, and the 20 year Reserve Study, along with the Long Term Reserve Projected Expenditures through 2032. According to the Reserve Study, the Reserve Fund is fully funded through 2024, allowing for a cost of living increase on expenses of 4% each year and 2% earnings on savings each year. Based on these projections, Gull Point can sustain reserve assessments of \$130 over a 13-year period. In addition, the proposed budget covers all operating costs supporting the \$399 portion of the rate to cover expenses. Staff also reviewed responses to data requests, as well as touring the wastewater plant with a DNREC Compliance Specialist and the wastewater operator for White Marsh Environmental System, Inc. Staff also had discussions with the operator regarding the anticipated work that will be done, as well as improvements and changes that have been done since 2008 when the operator began work at the facility.

### Staff's Recommendation:

Staff has reviewed Gull Point's financial and cost data and has determined that the rate reduction proposed results in just and reasonable rates and is in the public interest. Staff recommends the Commission approve the application for the annual rate of \$529, a reduction of \$31 a year.

Staff recommends that as part of Gull Point's next rate application, Gull Point provide an assessment of the collection system because this was not addressed in the Reserve Study. Specifically, the inspection of the collection system by the Gull Point Maintenance Supervisor is limited to locating manholes and cleanouts, installing risers where necessary, and visually inspecting for any issues. While this level of effort is important and should be continued, Staff believes that a proactive investigation of the condition of the sewer mains could avoid some serious problems in the long run.

Staff also recommends that Gull Point complete the effort to locate all of the service laterals and map them.



WHEREAS, on April 27, 2011, Gull Point Condominium Association ("Gull Point")<sup>i</sup> filed an application with the Delaware Public Service Commission (the "Commission") requesting approval of a decrease in its rate for wastewater service from \$560.00 per year to \$529.00 per year;<sup>2</sup> and

WHEREAS, 26 Del. C. §306(a)(1) permits the Commission to suspend the operation of a utility's proposed rate change for a period not to exceed seven months after the utility's application; and

WHEREAS, Staff recommends that the requested rate decrease be suspended pending Staff's investigation into the justness and reasonableness of the proposed rate; and

WHEREAS, it has come to the attention of Staff that Gull Point has been operating under a temporary permit to provide wastewater service since 2007 when the Commission authorized Utility Systems, Inc.'s transfer of the wastewater system to GullPoint;

The formal legal name of the company is "Association of Owners of Gull Point Condominium, Inc.;" this name was inadvertently omitted from PSC Order 7201, which granted Gull Point its temporary operating permit for wastewater services.

'Gull Point's application stated that its current annual rate for wastewater service was \$562.00; however, it subsequently informed Staff that this was a typographical error.

## NOW, THEREFORE, IT IS HEREBY ORDERED BY THE AFFIRMATIVE VOTE OF NOT FEWER THAN THREE COMMISSIONERS:

1. That the rate filed by Gull Point Condominium Association ("Gull Point") on April 27, 2011, is hereby suspended pursuant to 26 *Del. C.* §306(a) (1) and shall not be placed into force or effect except pursuant to law or further Order of the Commission, and then only to the extent such law or further Commission Order may permit or allow.

2. That Gull Point shall give public notice of the filing of its application with the proposed rate change, the deadline for interventions and written comments, and the hearing date by sending a letter to each customer at his/her last known mailing address by first-class mail, postage prepaid. Such letters shall be mailed to customers no later than June 3, 2011, in a form provided by Commission Staff.

3. That Gull Point shall provide the Commission with written notice that it has complied with the mailing requirements set forth in Ordering Paragraph No. 2 on or before June 10, 2011.

4. That the Commission will conduct a hearing in this matter at its regular meeting on **Tuesday**, **July 26**, **2011**, at 1:00 p.m., to determine the justness and reasonableness of the proposed decreased rates or, if any dispute remains concerning the proposed rate, to consider whether the matter should be referred to a hearing examiner for further proceedings. Julie M. Donoghue, Deputy Attorney General and Staff Counsel, is designated as counsel for this matter. 5. That the deadline for filing petitions to intervene pursuant to Rule 1001-2.9 of the Commission's Rules of Practice and  $\mathbf{2}$ 

Procedure, and for filing written comment, shall be Friday, July 1, 2011. Late-filed petitions to intervene will not be granted unless good cause is shown. Hearing Examiner Mark Lawrence is designated Hearing Examiner in this matter for the purposes of granting or denying intervention petitions and for admission of counsel pro *hac* vice.

Gull Point is hereby placed on notice that the costs of the proceedings may be charged to it under the provisions of 26 Del.C. §114(b) (1).

7. That Gull Point shall file an application with the Commission for the issuance of a Certificate of Public Convenience and Necessity as soon as practicable, but no later than July 31, 2011.

8. That the Commission reserves the jurisdiction and authority to enter such further Orders in this matter as may be deemed necessary or proper.
