ORDER NO. 8169

AND NOW, this 3rd day of July 2012, the Commission determines and orders the following:

WHEREAS, on June 20, 2012, Delmarva Power & Light Company ("Delmarva") filed a petition¹ ("Petition") requesting that the Commission amend the regulations set forth in 26 Del. Admin. C. §3002, "Regulations Governing Termination of Residential Electric or Natural Gas Service by Public Utilities for Non-Payment During Extreme Seasonal Temperature Conditions" (the "Regulations"); and

WHEREAS, Delmarva noted in its Petition that pursuant to PSC Order No. 7420 in PSC Docket No. 07-28, Delmarva is completing the installation of electric advanced metering infrastructure ("AMI") in its Delaware electric service territory. AMI gives Delmarva the ability to disconnect electric service remotely, thus avoiding the

¹ Although the filing was entitled "Application of Delmarva Power & Light Company to Amend the Regulations Pertaining to the Method of Service Disconnection for Electric Companies," under 26 Del. Admin. C. §1001-1.2, an "Application" means "a document in which a person seeks a certification, permit, license, or other approval, ruling or authorization from the Commission." Because Delmarva's filing is a request for relief which is not an application or a complaint, this filing is more properly entitled a "Petition" under 26 Del. Admin. C. §1001-1.2.

personnel, fuel, and equipment costs of sending an employee to physically disconnect service; and

WHEREAS, Delmarva also noted in its Petition that the Staff of the Public Service Commission ("Staff") and the Division of the Public Advocate ("DPA") have agreed that the Regulations should be amended to allow Delmarva and Delmarva's customers to realize the benefits of the installation of AMI; and

WHEREAS, Staff submitted a memorandum to the Commission dated July 3, 2012, in which it supported the re-opening of this docket;

NOW, THEREFORE, IT IS HEREBY ORDERED BY THE AFFIRMATIVE VOTE OF NOT FEWER THAN THREE COMMISSIONERS:

- 1. The Commission determines that good cause exists to re-open this regulation docket.
- 2. Pursuant to 26 Del. C. §209(a) (1) and 29 Del. C. §10111 et seq., the Commission proposes to revise and/or amend the "Regulations Governing Termination of Residential Electric or Natural Gas Service by Utilities for Non-Payment During Extreme Seasonal Temperature Conditions," 26 Del. Admin. C. §3002 (the "Regulations").
- 3. The Secretary of the Commission shall cause a copy of this Order and the enclosed notice to be sent by U.S. mail to all jurisdictional electric distribution utilities and all jurisdictional gas public utilities currently operating in Delaware and all persons who have made timely written requests for advance notice of the Commission's regulation-making proceedings.
- 4. The Secretary of the Commission shall cause a copy of the Public Notice attached as Exhibit "A" to be published in The News

<u>Journal</u> and <u>Delaware State News</u> newspapers in two column format, outlined in black, on or before Friday, July 27, 2012.

- 5. After receiving any comments solicited by the public notice and after conducting any such workshops as Staff deems necessary, Staff shall submit to the Commission proposals for revisions and/or amendments to the existing Regulations. If the Commission approves such proposed revisions and/or amendments, the Commission will then propose such rules and regulations for adoption under the procedures set forth in 29 Del. C. §§1133 and 10115 to 10118.
- 6. Julie M. Donoghue, Esquire, is designated Staff Counsel for this matter.
- 7. Delmarva Power & Light Company is hereby notified that it may be charged for the cost of this proceeding under 26 Del. C. §114.
- 8. The Commission reserves the jurisdiction and authority to enter such further Orders in this matter as may be deemed necessary or proper.

PUBLIC NOTICE

SOLICITING COMMENTS CONCERNING REVISIONS TO THE RULES AND REGULATIONS OF THE PUBLIC SERVICE COMMISSION

On June 20, 2012, Delmarva Power & Light Company ("Delmarva") filed a petition with the Public Service Commission ("the Commission") requesting that the Commission amend the regulations set forth in 26 Del. Admin. C. \$3002, "Regulations Governing Termination of Residential Electric or Natural Gas Service by Public Utilities for Non-Payment During Extreme Seasonal Temperature Conditions" (the "Regulations"). These Regulations were originally adopted in PSC Regulation Docket No. 3 by PSC Order No. 1990 (October 30, 1979) and revised in PSC Order No. 2143 (October 28, 1980). On April 15, 2003, PSC Order No. 6148 re-opened the Regulations, re-captioned the Regulations, and re-numbered the docket as PSC Regulation Docket No. 53. The Regulations were further modified by the Commission in PSC Order No. 6325 (December 9, 2003).

The existing Regulations establish uniform procedures which must be followed prior to termination of service for non-payment during the heating or cooling season and apply to all public utilities subject to the jurisdiction of the Commission. See 26 Del. Admin. C. §3002-1.2. In PSC Order No. 8169 (July 3, 2012), the Commission accepted Delmarva's petition to re-open these Regulations. The Commission agreed to consider amendments proposed by Delmarva which would modify the Regulations to:

- (a) Allow electric utilities to utilize the new technology of the installed electric advanced metering infrastructure ("AMI") to disconnect electric service remotely, to not require an electric employee to make a reasonable good faith attempt to make personal contact at the premises to be disconnected prior to termination of service, and replacing this personal contact requirement with a requirement that the electric utility make at least one attempt to contact the customer by telephone; but
- (b) Maintain the existing Regulations for natural gas utilities and the requirements regarding final personal contract prior to termination of gas service.

As the first step in the process, Delmarva has proposed amendments and revisions to the existing Regulations for the

Commission's later consideration. To aid in this initial process, the Commission and its Staff now solicit comments concerning adopting amendments and/or revisions to the existing Regulations.
