**NOTICE OF REQUEST FOR APPROVAL OF AN INTERCONNECTION  
AGREEMENT UNDER THE  
TELECOMMUNICATIONS ACT OF 1996**

**PLEASE TAKE NOTICE** that on December 1, 2016, Verizon Delaware LLC, f/k/a Verizon Delaware Inc. (“Verizon”), and Onvoy, LLC (Successor to Onvoy, Inc.) and collectively with Verizon (the “Applicants”) filed an application (the “Application”) requesting the Public Service Commission (“PSC” or the “Commission”) to approve an Amendment No. 1 (“Amendment”) to the Interconnection Agreement which went into effect in PSC Docket No. 15-0666 (January 30, 2015).

The pertinent provisions of the Amendment include:

- Compensation for Reciprocal Compensation Traffic at rates specified in the Amendment; and
- The terms and conditions with which the Reciprocal Compensation Rate shall or shall not be applied;

Any person who wishes to protest or to comment upon this application must do so in a written document filed with the Commission and served upon the Applicants on or before January 6, 2017. Comments should focus on the criteria for review set forth in 47 U.S.C. § 252(e)(2)(A) and whether the Amendment is consistent with applicable state law, regulation, or policy. In the absence of any good faith protest, the Commission will allow the Agreement to become effective on March 1, 2017.
