#### ORDER NO. 7819

**AND NOW**, this  $17^{\text{th}}$  day of August, 2010, the Commission determines and Orders the following:

WHEREAS, the Commission having, on August 17, 2010, conducted a public evidentiary hearing on the application filed by Mediacom Delaware, LLC ("Mediacom"), seeking approval to make changes to the maximum permitted rate for basic cable television service ("BST"), and to the charges for regulated equipment and installation services associated with the BST provided by Mediacom in the unincorporated areas of southern Sussex County designated as Community Identifier Units CIUD DE0030, 0025, and 0032; and

whereas, Mediacom published notice of its filing to make rate changes in the <u>Delaware State News</u> and the <u>Sussex County Post</u> on July 16, 2010 and July 22, 2010, respectively. No person or entity filed any comments in response to such notice.

WHEREAS, based on the evidence presented at the hearing, the Commission having determined that the proposed maximum permitted BST rate set forth in FCC Form 1240 (filed May 28, 2010), has been calculated consistent with the governing rules of the Federal

Communications Commission ("FCC") pertaining to BST rate regulation; and

WHEREAS, based on the evidence presented at the hearing, the Commission having determined that the maximum permitted regulated equipment and installation charges set forth in FCC Form 1205 (filed May 28, 2010) have been calculated in accordance with the governing rules of the FCC related to regulated equipment and installation activities associated with BST service;

# NOW, THEREFORE, IT IS HEREBY ORDERED, BY THE AFFIRMATIVE VOTE OF NOT FEWER THAN THREE COMMISSIONERS,

1. That the Commission hereby approves the maximum permitted rate for basic cable service and regulated equipment and installation charges as set forth below for service offered by Mediacom Delaware, LLC, in the unincorporated areas of Sussex County designated as Community Identifier Units CUID DE0030, 0025, and 0032:
