ORDER NO. 7975

AND NOW, this 7th day of June, 2011:

WHEREAS, on March 31, 2010, Artesian Water Company, Inc. ("Artesian" or "Applicant") filed an application ("Application") with the Public Service Commission (the "Commission") seeking a Certificate of Public Convenience and Necessity ("CPCN") to expand its facilities and operations in order to provide water services to fifty-two parcels of land in Southern New Castle County, Delaware ("Proposed Service Area"). The basis for the Application is Artesian's possession of petitions requesting water services signed by all of the owners of the parcels of land comprising the Proposed Service Area in accordance with 26 Del. C. §203C(e)(1)b.2. With its Application, Artesian filed evidence that it had sent by certified mail to the landowners in the Proposed Service Area notice of its application and the options available to the affected landowners. In addition, on Staff's direction, Artesian published notice of its Application in two newspapers of general circulation. No comments regarding the Applicant or this Application have been received;

WHEREAS, on May 4, 2011, Artesian amended its Application to remove three parcels of land from the Proposed Service Area (New Castle County Tax Map Parcel Numbers 13-009.00-388, 13-013.00-144, and 13-017.00-009). There are now forty-nine parcels of land in the Proposed Service Area;

WHEREAS, the Commission Staff has completed its review and investigation of the Application and the Applicant. In a May 19, 2011, Memorandum to the Commission, Staff reports that Artesian's Application meets all requirements for the granting of a CPCN under 26 Del. C. §203C and the Commission's *Regulations Governing Water Utilities Including the Public Service Commission's Jurisdiction to Grant and Revoke Certificates of Public Convenience and Necessity*, 26 Del. Admin. C. §2002 et al., and therefore recommends approval of the Application; and

WHEREAS, for these reasons, the Commission finds that Artesian has met all requirements for the granting of a CPCN and, therefore, the Commission shall approve the Application in PSC Docket No. 10-CPCN-09 as filed on March 31, 2010, and amended on May 4, 2011.

NOW, THEREFORE, IT IS HEREBY ORDERED BY THE AFFIRMATIVE

VOTE OF NOT FEWER THAN THREE COMMISSIONERS:

1. That, pursuant to 26 Del. C. §203C(e), to the extent it is consistent with this Order, a Certificate of Public Convenience and Necessity is granted to Artesian Water Company, Inc. to serve the area more specifically identified by the New Castle County Tax Map Parcel Numbers shown in the attached Exhibit "A" of this Order.

2. That Artesian Water Company, Inc., shall comply with any and all federal, state, county, and local statutes, ordinances, orders, regulations, rules, and permit conditions that are applicable, or may become applicable, to any matter involving water utility services provided to the service territory granted by this Certificate of Public Convenience and Necessity.

3. That the Commission reserves the jurisdiction and authority to enter such further Orders in this matter as may be deemed necessary or proper.
