ORDER NO. 8104

AND NOW, this 31st day of January, 2012:

WHEREAS, by Order No. 7485 dated November 21, 2008, the Delaware Public Service Commission (the "Commission") opened this docket for the filing of notices, pleadings, or papers relating to a workshop held on November 20, 2008 to receive a presentation from Delmarva relating to Delmarva Power & Light Company's ("Delmarva") demand response programs (the "Workshop"); and

WHEREAS, in that same Order, the Commission directed Delmarva Power and Light Company ("Delmarva") and any other interested parties to "convene at a collaborative workshop to determine the viability of implementing any reasonable demand-side management or demand response programs in the near term;" and

WHEREAS, Delmarva met with representatives of the Commission Staff and the Division of the Public Advocate ("DPA") on several occasions to discuss its Advanced Metering Initiative ("AMI") and implementation of demand response programs such as dynamic pricing and direct load control ("DLC"); and

WHEREAS, on March 23, 2011, Delmarva filed with the Commission an application for approval of a proposed dynamic pricing plan; and

WHEREAS, by Order No. 8094 dated December 20, 2011, the Commission approved a settlement reached by Delmarva, Staff and the DPA to implement a dynamic pricing plan; and

WHEREAS, on July 29, 2011 Delmarva filed with the Commission an application for approval of a proposal to establish a new residential air conditioning cycling program; and

WHEREAS, by Order No. 8015 dated August 23, 2011, the Commission opened Docket No. 11-330 to consider Delmarva's application, which docket is currently pending; and

WHEREAS, under these circumstances, the Commission does not believe there is any need for this docket to remain open;

NOW THEREFORE, IT IS HEREBY ORDERED BY THE AFFIRMATIVE VOTE OF NO FEWER THAN THREE COMMISSIONERS:

1. That this docket is closed.
2. That the Commission retains jurisdiction and authority to enter such further orders as may be deemed necessary or proper.
