ORDER NO. 8121

AND NOW, this 6th day of March, 2012, the Public Service Commission (the "Commission") determines and orders the following:

WHEREAS, on April 25, 2006, in PSC Order No. 6905, the Commission granted a Certificate of Public Convenience and Necessity ("CPCN") to Linder & Company, Inc. ("Linder") to provide wastewater services for customers in the service territory encompassing the development of Bethany Bay, located near the town of Ocean View in Sussex County, Delaware. The service territory was described in Exhibit "A" to PSC Order No. 6905 (the "Bethany Bay Service Area"); and

WHEREAS, the Commission retained jurisdiction in this matter, including the authority to enter such further Orders and conduct such further proceedings as it deemed just, proper, or appropriate; and

WHEREAS, on May 10, 2011, Linder filed with the Commission an application requesting that the Commission approve Linder's request to abandon or discontinue providing wastewater operations or services for the Bethany Bay Service Area as previously described in PSC Order No. 6905, Exhibit "A"; and

WHEREAS, 26 Del. C. §203A(c)(1) provides that no public utility shall abandon or discontinue, in whole or in part, any business,

operations, or services provided under a CPCN or otherwise, which are subject to jurisdiction of the Commission without first having received Commission approval for such abandonment or discontinuance; and

WHEREAS, Sussex County has by Resolution dated September 23, 2003 (Resolution R 026 03), extended the boundary of the Bethany Bay Sanitary Sewer District to encompass the Bethany Bay Service Area; and

WHEREAS, Linder provided information to the Commission Staff to show Sussex County began providing wastewater service to Bethany Bay customers through a temporary connection as of August 4, 2007. In addition, Sussex County has confirmed with the Commission Staff that the collection system at Bethany Bay has been diverted to the Sussex County Regional Wastewater Facility for treatment and disposal and is currently part of the County's Millville Sewer District; and

WHEREAS, Linder is not presently serving any wastewater customers located in the Bethany Bay Service Area; and

WHEREAS, Linder has provided to the Commission Staff such information necessary for Staff's review of the abandonment application. Based on its review, Staff recommends that the Commission approve Linder's abandonment application because Linder has shown that the abandonment or discontinuance is reasonable, necessary, and not unduly disruptive to the present or future public convenience and necessity as required by 26 Del. C. §203A(c)(3);

NOW, THEREFORE, IT IS HEREBY ORDERED BY THE AFFIRMATIVE VOTE OF NOT FEWER THAN THREE COMMISSIONERS:

1. Linder & Company, Inc.'s application to abandon or discontinue providing wastewater operations or services to the service

the town of Ocean View in Sussex County, Delaware, as described in the attached Exhibit "A," is hereby granted and approved effective with the date of this Order.
