### ORDER NO. 8227

**AND NOW**, this 9<sup>th</sup> day of October, 2012:

WHEREAS, on September 21, 2012, Chesapeake Utilities Corporation ("Chesapeake" or "the Company") filed with the Delaware Public Service Commission (the "Commission") the above-captioned application (the "Application") seeking approval to change its Gas Sales Service Rates ("GSR") effective on November 1, 2012, as follows: (1) decrease the Company's current GSR rate from \$1.027 per Ccf to \$0.997 per Ccf for customers served under rate schedules RS-1, RS-2, GS, MVS and LVS; (2) decrease the Company's current GSR rate from \$0.592 per Ccf to \$0.519 per Ccf for customers served under rate schedules GLR and GLO; (3) decrease the Company's current GSR rate from \$0.830 per Ccf to \$0.817 per Ccf for customers served under rate schedule HLFS; (4) maintain the Company's firm balancing rate for transportation customers served under rate schedule LVS at \$0.063; (5) increase the Company's firm balancing rate for transportation customers served under rate schedule HLFS from \$0.021 per Ccf to \$0.022 per Ccf; and (6) maintain the Company's interruptible balancing rate for transportation customers served under rate schedule ITS at \$0.001 per Ccf; and

WHEREAS, by letter dated September 21, 2012, Chesapeake indicated

that due to staffing vacancies, it sought an extension of time to file its GSR application, which was due sixty days prior to November 1 of each year (pursuant to 26 Del. C. §304 and Chesapeake's current GSR tariff). The Commission Staff supports such time extension and believes that good cause exists for waiving the 60-day notice requirement in this matter; and

WHEREAS, the Commission has determined, pursuant to 26 Del. C. §§304 and 306, that the proposed GSR changes should be permitted to become effective for usage on and after November 1, 2012, subject to refund and pending the Commission's further review and final decision;

# NOW, THEREFORE, IT IS HEREBY ORDERED BY THE AFFIRMATIVE VOTE OF NOT FEWER THAN THREE COMMISSIONERS:

- 1. That the request filed by Chesapeake Utilities Corporation on September 21, 2012, seeking to extend the time for it to file its application to adjust its Gas Sales Service Rates for the 2012-2013 effective period is hereby granted. Under 26 Del. C. §304(a), the Commission finds good cause exists in this matter and therefore waives the sixty-day notice period. Thus, the Commission accepts the application filed by Chesapeake Utilities Corporation on September 21, 2012, for rates effective November 1, 2012.
- 2. That pursuant to 26 Del. C. §§303(b), 304, and 306, the following proposed changes to the Gas Sales Service rates, firm balancing rates and interruptible balancing rate of Chesapeake Utilities Corporation, and the accompanying proposed tariff revisions set forth in the application filed by Chesapeake Utilities Corporation ("Application"), are permitted to become effective for natural gas usage on or after November 1, 2012, subject to refund and pending the

- 3. That Robert J. Howatt is designated as the Hearing Examiner for this docket pursuant to 26 Del. C. §502 and 29 Del. C. ch. 101. Hearing Examiner Howatt shall schedule and conduct such public evidentiary hearings as may be necessary or appropriate to develop a full and complete record concerning this matter. Hearing Examiner Howatt shall thereafter report to the Commission his proposed findings and recommendations based on the evidence presented. Pursuant to 26 Del. Admin. C. §1001-2.9.3, Hearing Examiner Howatt is delegated the authority to grant or deny petitions to intervene. In addition, Hearing Examiner Howatt is delegated the authority under 26 Del. C. §102A to determine the content, form, and manner of any further notice in this matter and is delegated the authority under 26 Del. Admin. C. §1001-2.1 to grant applications of counsel for admission pro hac vice.
- 4. That Chesapeake Utilities Corporation shall give public notice of the filing of this Application, with the proposed rate changes and this action by the Commission, by publishing notice in the form attached hereto as **Exhibit "A"** in two-column format, outlined in

black, in the legal classified section of <u>The News Journal</u> newspaper on **Tuesday**, **October 16**, **2012** and the <u>Delaware State News</u> newspaper on **Wednesday**, **October 17**, **2012**. Chesapeake Utilities Corporation shall submit proof of such publications as soon as possible, but no later than the commencement of any evidentiary hearings concerning this matter.

- 5. That Chesapeake Utilities Corporation is hereby put on notice that it will be charged the costs incurred in connection with this proceeding under the provisions of 26 Del. C. §114(b)(1).
- 6. That the Commission reserves the jurisdiction and authority to enter such further Orders in this matter as may be deemed necessary or proper.

### Chesapeake Utilities Corporation's Gas Sales Service Rates Application

Pursuant to 26 Del. C. §§303(b), 304, and 306, Chesapeake Utilities Corporation ("Chesapeake" or "the Company") has filed an application (the "Application") with the Delaware Public Service Commission (the "Commission") seeking to change its Gas Sales Service ("GSR") Rates as follows:

RS-1, RS-2, GS, MVS, LVS	\$1.027 per Ccf	\$0.997 per Ccf
GLR, GLO	\$0.592 per Ccf	\$0.519 per Ccf
HLFS	\$0.830 per Ccf	\$0.817 per Ccf

Compared to the rates currently in effect, an average RS-2 customer using 700 Ccf per year will experience an annual decrease of approximately 2%, or \$1.75 per month. During the winter heating season, a typical RS-2 customer using 120 Ccf per winter month will experience a decrease of approximately 2%, or \$3.60 per winter month.

The Company has also proposed the following changes to its firm and interruptible transportation balancing rates:
