ORDER NO. 8649

AND NOW, this 30th day of September, 2014, the Delaware Public Service Commission ("Commission") determines and orders the following:

WHEREAS, on August 28, 2013, Delmarva Power & Light Company ("Delmarva") filed with the Commission the above-captioned application ("Application") seeking approval to modify its Gas Cost Rates ("GCR") effective on November 1, 2013, with proration; and

WHEREAS, following an evidentiary hearing before Hearing Examiner R. Campbell Hay, and submission of a Proposed Settlement Agreement by Delmarva, Commission Staff and the Division of the Public Advocate ("DPA"), the Commission approved the Application adopting the June 19, 2014 Findings and Recommendations of the Hearing Examiner and approved the Proposed Settlement Agreement pursuant to Commission Order No. 8578, dated July 8, 2014; and

WHEREAS, Section 12 of the Proposed Settlement Agreement requires Delmarva to submit a regulatory filing to the Commission on or before October 1, 2014, in which Delmarva will propose changes to the balancing fees associated with the GCR ("Regulatory Filing"); and

WHEREAS, Delmarva has been working on the Regulatory Filing and has met with Commission Staff and DPA to discuss its findings and suggested revisions to the balancing fees; and

WHEREAS, Commission Staff, DPA and Delmarva agree that more time is needed to further refine the Regulatory Filing, and therefore Delmarva, with the concurrence of Commission Staff and the DPA, is requesting an extension of the deadline to file the Regulatory Filing to January 5, 2015;

**NOW, THEREFORE, IT IS HEREBY ORDERED BY THE AFFIRMATIVE
VOTE OF NOT FEWER THAN THREE COMMISSIONERS:**

1. The Commission grants the request of Delmarva to extend the deadline for the Regulatory Filing to January 5, 2015.
2. The Commission reserves the jurisdiction and authority to enter such further Orders in this matter as may be deemed necessary or proper.
