

**BLOOM ENERGY CORPORATION'S PETITION FOR INTERVENTION**

Bloom Energy Corporation, by and through its undersigned counsel and pursuant to Rule 21 of the Public Service Commission Rules of Practice and Procedure, respectfully petitions for leave to intervene as a party in this matter. In support of its Petition, Bloom states as follows:

1. Bloom Energy Corporation ("Bloom") is Delaware corporation, and a fuel cell manufacturer with its principal place of business in Sunnyvale, California. Bloom has announced plans to develop a manufacturing facility in Newark, Delaware. Through the development of its manufacturing facility, Bloom expects to become a "Qualified Fuel Cell Provider" as defined in 26 *Del. C.* § 352 (16).

2. The applicant in this proceeding, Delmarva Power & Light Company ("Delmarva"), has submitted testimony of Joshua A. Richman, Vice President of Business Development of Bloom, in support the application. Mr. Richman, and another officer of Bloom, Martin J. 3. Bloom has coordinated with Delmarva in connection with the proposed tariffs that are the subject of Delmarva's application. If the proposed tariffs are adopted by the Commission, an affiliate of Bloom's will deploy the fuel cell energy servers that are the foundation for the project.

4. In light of Bloom's status as a proposed Qualified Fuel Cell Provider and a proposed operator of a Qualified Fuel Cell Provider Project, Bloom has economic and business interests in connection with this proceeding and the proposed approval of the proposed tariffs.

5. While Bloom's interests are aligned with those of Delmarva, they are separate and potentially different, and accordingly, Bloom's interests in this proceeding will not be adequately represented without being granted intervenor status, and the public interest will be served by Bloom's participation as a party to this proceeding.

WHEREFORE, petitioner/proposed intervenor Bloom Energy Corporation respectfully requests that its Petition for Intervention be granted, and that the Commission adopt the tariffs, in their entirety, as submitted in this proceeding on August 19, 2011.
