**TO: ALL ELECTRIC AND GAS CUSTOMERS OF DELMARVA POWER & LIGHT
COMPANY AND OTHER INTERESTED PERSONS**

On July 12, 2018, Delmarva Power & Light Company ("Delmarva" or the "Company") filed an application ("Application") with the Delaware Public Service Commission ("Commission") for approval of a voluntary program for prepaid power (the "Program"). According to Delmarva, the Program will give customers the option to prepay for their anticipated energy consumption, track how their usage is trending in relation to their pre-payment, and add to their prepaid account bank as needed.

The Program will entail interactions with customers that are not addressed by Commission regulations or Delmarva's electric and gas tariffs. For this reason, Delmarva seeks approval to waive certain billing-related provisions of its electric and natural gas tariffs as they apply to the Program and to implement a new rider for its electric and gas tariffs to govern the Program.

The Program also implicates certain termination-related Commission regulations with respect to notice before service is terminated. Delmarva seeks a ruling that these regulations do not apply in the

context of this Program or that they may be waived to the extent they do apply to the Program.

The Commission will hold three (3) public comment sessions on this Application at the times and places specified below:

If you wish to file written comments or objections, ***you must do so on or before November 30, 2018.*** If you want to formally participate as a party in this matter, with the right to present evidence and be represented by counsel, you must file with the Commission a written petition for leave to intervene in accordance with the requirements of the Commission's Rules of Practice and Procedure (26 Del.
