**TO: ALL NATURAL GAS CUSTOMERS OF DELMARVA POWER & LIGHT COMPANY AND  
OTHER INTERESTED PERSONS**

On February 22, 2019, Delmarva Power & Light ("Delmarva") filed a Petition with the Delaware Public Service Commission to build a new satellite natural gas storage facility in New Castle County, Delaware (PSC Docket No. 19-0110). The Commission will render a decision after holding public evidentiary hearings, which will be conducted upon due public notice, and will render its decision based on the record evidence.

If the Commission does not receive any petitions to intervene, material objections, or written comments raising significant issues, the Commission may, by later order, rescind the designation of Glenn Kenton as the Hearing Examiner for this proceeding, and consider the matter after a duly noticed evidentiary hearing at a regularly-scheduled Commission meeting.

You are invited to review Delmarva's Petition and supporting documents to determine how your interests may be affected by going to DelaFile (<https://delafile.delaware.gov>), the Commission's file management system, and searching for Docket No. 19-0110.

Interested persons or entities are afforded the opportunity to file comments or objections to the proposed construction. Such comments or objections shall be filed **on or before April 30, 2019** using DelaFile.

If you wish to formally participate as a party in this matter, with the right to present evidence and be represented by counsel, you must file with the Commission a petition for leave to intervene in accordance with the requirements of the Commission's Rules of Practice and Procedure (26 Del. Admin. C. § 1001-2.9) **on or before April 30, 2019**. All such petitions should be also be filed in DelaFile according to the Commission's Rules (26 Del. Admin. C. § 1001-1.6.4). Petitions for intervention that are not received by the Commission **on or before April 30, 2019**, will not be granted unless good cause is shown.
