

# Filing Instructions for a Delaware Certified Electric Suppliers/Broker Acquiring Ownership of a Delaware Certified Electric Supplier/Broker

- **I. Where to File:** Applications should be filed in the Commission's electronic filing system, DelaFile, which can be accessed at https://delafile.delaware.gov/
- **II.** What to File: The acquiring Delaware Electric Supplier Certificate holder (" the Applicant") must use the attached form to submit the Application. (Please remove this instruction sheet prior to filing). To submit an application please provide the \$100 non-refundable application fee, all exhibits, affidavits, and other attachments. All exhibits should be clearly identified. For example, Exhibit A should be marked "Exhibit A Delaware Certificate of Good Standing." Each exhibit should be attached as a separate document to the filing in DelaFile.
- III. Confidentiality: All information disclosed in this application is considered public information unless specifically labeled confidential. The Applicant has the responsibility to disclose to the Commission Secretary what is privileged or confidential information not otherwise available to the public. The Applicant should attach in DelaFile one copy of all confidential information, documents should be stamped "CONFIDENTIAL" at the top in clear and conspicuous letters, the security level for this document in DelaFile should be designated "confidential"; a separate redacted version of all confidential documents should be attached to the filing in DelaFile, and the security level in DelaFile should be designated "public." If your Application includes confidential information, please complete Attachment C. For more information, see 26 Del. Admin. C. § 1001 Rules of Practice and Procedure of the Delaware Public Service Commission.
- **IV. Material Changes:** Applicants shall inform Staff of any material changes in any information submitted in the application that occur from the time the application is submitted to the time the Commission considers the application. Failure to provide such notice within ten (10) Business Days after any material change may be grounds for rejection of this application.

Incomplete applications or those not including the necessary fees, supporting documentation or information may be rejected and processing delayed. The Applicant must then refile the application with the required information and filing fee.

If the application when submitted and reviewed is found to be deficient, the Applicant will be given the opportunity to provide the additional information; however, an incomplete or abandoned application will be closed four (4) months after the initial filing date, unless such time period is extended by the Commission.
