In addition to the foregoing Annual Service Tariff, each new customer of Pickering Beach Water Company will be required to pay the following Tapping Service Tariff, when and as rendered by the Company, viz:

MISCELLANEOUS SERVICE TARIFF

In addition to the foregoing Annual Service Tariff and Tapping Service Tariff, each customer of Pickering Beach Water Company will be required to pay the following Miscellaneous Service Tariff when and as required by the Company, viz:

### MEMBERSHIP

In addition to the foregoing Annual Service Tariff, Tapping Service Tariff, and Miscellaneous Service Tariff, each new customer of The Pickering Beach Water Company will be required to purchase membership in Pickering Beach Company, a non-profit Delaware Corporation. Membership in Pickering Beach Company shall be limited to beneficial owners of residential parcels or lots improved by a dwelling house at Pickering Beach in Kent County, Delaware, and shall terminate on the member's ceasing to be a beneficial owner of a residential parcel or lot, unless such membership is assigned to a subsequent owner of such residential parcel or lot.

As to any one of the existing thirty-eight (38) customers of The Pickering Beach Water Company, the cost of membership in Pickering Beach Company shall be the sum of Two Thousand Seven Hundred Dollars (\$2,700.00), subject to appreciation of twelve percent beginning on April 1, 1989, then on January 1, 1990, and then annually on the first day of January of each year thereafter, i.e. the cost of membership purchased during prior to April 1, 1989 is \$2,700.00, the cost of membership purchased after March 31, 1989, but prior to January 1, 1990, will be \$3,024.00, the cost of membership purchased after December 31, 1989, but prior to January 1, 1991, will be \$3,386.88, etc., Such membership in Pickering Beach Company may be either paid for in full at the time of application or paid with interest at the rate of twelve percent per annum on the unpaid balance from the date of membership application, in fifteen annual amortized installments of principal and interest, due on the first day of January of each year after the date of membership application, with the first installment due on the first day of January of the year immediately after membership application and the final installment, if not sooner paid, due on the first day of January on the 15th year after membership application, i.e. should membership be purchased during prior to January 1, 1990, the first installment is due January 1, 1990, and the final installment is due January 1, 2004. The first installment may be adjusted to allow credit for unearned interest.

As to any new customer not being currently served by The Pickering Beach Water Company, the cost of membership in Pickering Beach Company shall be the sum of Two Thousand Seven Hundred Dollars (\$2,700.00). Membership in Pickering Beach Company may be either paid for in full at the time of application or paid with interest at the rate of six percent per annum on the unpaid balance from the date of membership application, in three annual amortized installments of principal and interest, due on the first day of January of each year, with the first installment due on the first day of January of the year immediately after membership application and the final installment, if not sooner paid, due on the first day of January on the third year after membership application, i.e. should membership be purchased prior to January 1, 1990, the first installment is due January 1, 1990, and the final installment is due January 1, 1992. The first installment may be adjusted to allow credit for unearned interest.
