On September 12, 2024 Tidewater Utilities, Inc., filed an application with the Delaware Public Service Commission ("PSC") for a Certificate of Public Convenience and Necessity ("CPCN") to provide water services to the following parcels: (1) 134-7.00-1.00 - is a parcel located on the south side of Sussex Rd. and is located about 916 feet from the intersection of Sussex Rd. and Sandy Landing Rd. (2) 134-7.00-1.01 - is a parcel located on the south side of Sussex Rd. and is located about 1,173 feet from the intersection of Sussex Rd. and Sandy Landing Rd. (3) 135-5.00-129.00 - is a parcel located on the west side of McColleys Chapel Rd. and is located about 405 feet from the intersection of McColleys Chapel Rd. and Warrington Ct. (4) 230-6.00-36.00 – is a parcel located on the south side of White Birch Ln. and is located about 331 feet from the intersection of White Birch Ln. and Ladds Ln. (5) 230-13.00-18.03 - is a parcel located on the west side of Greentop Rd. and is located about 996 feet from the intersection of Greentop Rd. and Cooper Ave. (6) 230-13.00-164.04 – is a parcel located on the west side of Cabbage Way and is located about 733 feet from the intersection of Cabbage Way and Cabbage Pond Rd. The basis for the application is Tidewater Utilities, Inc. possession of a petition requesting water services signed by all of the landowners in the proposed service area as set forth in 26 Del. C. §203C(e)(1)b.

The PSC is investigating this matter to the extent deemed necessary to determine whether the CPCN should be granted. An evidentiary hearing on this application will not be held unless there is a meritorious request received within thirty (30) days of publication of this notice. A meritorious request is deemed to be one which sets forth reasonable grounds why a public hearing would be appropriate or would be in the public interest.

Pursuant to current law, property owners within the proposed CPCN service area may file an objection to the issuance of a CPCN to Tidewater Utilities, Inc. and may also choose to "opt-out" of inclusion in the proposed service area. Written notice of such objection or a decision to "opt-out" of inclusion in the proposed service area must be sent to the Delaware Public Service Commission at the following address within thirty (30) days after publication of this notice.
