On October 15, 2024 Tidewater Utilities, Inc., filed an application with the Delaware Public Service Commission ("PSC") for a Certificate of Public Convenience and Necessity ("CPCN") to provide water services to the following parcels: (1) 231-7.00-39.04 - is a parcel located on the west side of Marsh Rd. and is located about 1,775 feet from the intersection of Marsh Rd. and Seashore Hwy. (2) 233-15.00-52.16 - is a parcel located on the west side of Fox Rd. and is located about 85 feet from the intersection of Fox Rd. and Chase Ln.. (3) 235-12.00-4.00 - is a parcel located on the west side of Spicer Rd. and is located about 1,340 feet from the intersection of Spicer Rd. and Milton Ellendale Hwy. (4) 430-17.00-63.00 - is a parcel located on the east side of Cedar Corners Rd. and is located about 2,770 feet from the intersection of Cedar Corners Rd. and Deer Forest Rd. (5) 532-15.00-133.00 - is a parcel located on the south side of Tina Ave. and is located about 360 feet from the intersection of Tina Ave. and Denise Blvd. The basis for the application is Tidewater Utilities, Inc. possession of a petition requesting water services signed by all of the landowners in the proposed service area as set forth in 26 Del. C. §203C(e)(1)b.

The PSC is investigating this matter to the extent deemed necessary to determine whether the CPCN should be granted. An evidentiary hearing on this application will not be held unless there is a meritorious request received within thirty (30) days of publication of this notice. A meritorious request is deemed to be one which sets forth reasonable grounds why a public hearing would be appropriate or would be in the public interest.

Pursuant to current law, property owners within the proposed CPCN service area may file an objection to the issuance of a CPCN to Tidewater Utilities, Inc. and may also choose to "opt-out" of inclusion in the proposed service area. Written notice of such objection or a decision to "opt-out" of inclusion in the proposed service area must be sent to the Delaware Public Service Commission at the following address within thirty (30) days after publication of this notice.
