The basis for the application is that AWC is in receipt of a signed petition requesting water service from the landowner in each proposed service area as set forth in 26 Del. C. §203C(e)(1)(b)(2).

The PSC will investigate this matter to the extent deemed necessary to determine whether a CPCN should be granted.
