PUBLIC NOTICE OF APPLICATION OF TIDEWATER UTILITIES, INC. FOR AN INCREASE IN WATER BASE RATES

TO: WATER CUSTOMERS OF TIDEWATER UTILITIES, INC.:

On August 30, 2024, Tidewater Utilities, Inc. ("Tidewater") filed an application (the "Application") with the Delaware Public Service Commission (the "Commission") seeking approval for an increase in its water base rates and certain changes to its water tariff.

In its Application, Tidewater seeks an increase in annual operating revenues of \$10,330,878, or an increase of 25.66% over existing base rates.

The following is a comparison of Tidewater's present rates and proposed new rates for metered water on a quarterly and monthly basis:

On October 9, 2024, in Order No. 10555, the Commission, pursuant to 26 *Del. C.* § 306(a)(1), suspended the effect of the proposed changes pending further investigation, a public comment session, and public evidentiary hearings, which will be held later after further public notice. Furthermore, the Commission authorized Tidewater to place \$2.5 million of its proposed increases into effect subject to refund, pursuant to 26 *Del. C.* §306(c), sixty (60) days after the initial August 30, 2024 filing date.

The Commission will make its decision on this matter on the basis of the record evidence taken at the public evidentiary hearings. The Commission may approve or reject, in whole or in part, the proposed increase and tariff revisions and may approve a different method for allocating any increase that it approves.

You are invited to review Tidewater's application and supporting documents to determine how your interests may be affected by going to the Commission's electronic file management system, DelaFile, located at https://delafile.delaware.gov/, and by searching for Docket No. 24-0991.

If you wish to formally participate as a party in this matter, with the right to present evidence and be represented by counsel, you must file with the Commission a petition asking for leave to intervene in accordance with the requirements of the Commission's *Rules of Practice and Procedure* (26 *Del. Admin. C.* §1001-2.9) *on or before* Friday, November 15, 2024. All such petitions should be filed in DelaFile according to the Commission's rules (26 *Del. Admin. C.* §1001-1.6.4). Petitions filed after the deadline of October 25, 2024, will not be considered except for good cause shown.
