On August 30, 2024, Tidewater Utilities, Inc. ("Tidewater") filed an application (the "Application") with the Delaware Public Service Commission (the "Commission") seeking approval for an increase in its water base rates and certain changes to its water tariff.

In its Application, Tidewater seeks an increase in annual operating revenues of \$10,330,878, or an increase of 25.66% over existing base rates.

On October 9, 2024, in Order No. 10555, the Commission, pursuant to 26 *Del. C.* 306(a)(1), suspended the effect of the proposed changes pending further investigation, a public comment session, and public evidentiary hearings, which will be held later after further public

notice. Furthermore, the Commission authorized Tidewater to place \$2.5 million of its proposed increases into effect subject to refund, pursuant to 26 *Del. C.* §306(c), sixty (60) days after the initial August 30, 2024 filing date.

The Commission will make its decision on this matter on the basis of the record evidence taken at the public evidentiary hearings. The Commission may approve or reject, in whole or in part, the proposed increase and tariff revisions and may approve a different method for allocating any increase that it approves.
