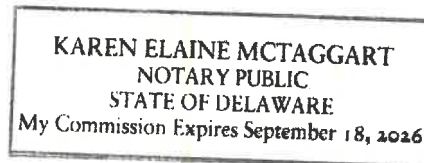

On October 17, 2025, Tidewater Utilities, Inc., filed an application with the Delaware Public Service Commission ("PSC") for a Certificate of Public Convenience and Necessity ("CPCN") to provide water services to the following parcels: (1) 5-00-15000-01-4404 - is a parcel located on the east side of Killens Pond Rd. and is located about 1727 feet from the intersection of Killens Pond Rd. and Paradise Alley Rd. (2) 5-00-15200-02-6503 - is a parcel located on the south side of Big Stone Beach Rd and is located about 245 feet from the intersection of Big Stone Beach Rd. and Paris Kirby Rd (3) 7-00-10902-02-1200 - is a parcel located on the east side of Clyde Dr. and is located about 412 feet from the intersection of Clyde Dr and Willow Grove Rd. (4) 9-00-09202-02-0200 - is a Parcel located on the west side of Reale Dr. and is located about 426 feet from intersection of Reale Dr. and Bryants Corner Rd. (5) 9-00-07503-01-4500 - is a Parcel located on the south side of Massey Dr. and is located at the intersection of Massey Dr. and Dorian Dr.

The basis for the application is Tidewater Utilities, Inc. possession of petition requesting water services signed by all of the landowners in the proposed service area as set forth in 26 Del. C. §203C(e)(1)b.

The PSC is investigating this matter to the extent deemed necessary to determine whether the CPCN should be granted. An evidentiary hearing on this application will not be held unless there is a meritorious request received within thirty (30) days of publication of this notice. A meritorious request is deemed to be one which sets forth reasonable grounds why a public hearing would be appropriate or would be in the public interest.

Pursuant to current law, property owners within the proposed CPCN service area may file an objection to the issuance of a CPCN to Tidewater Utilities, Inc. and may also choose to "opt-out" of inclusion in the proposed service area. Written notice of such objection or a decision to "opt-out" of inclusion in the proposed service area must be sent to the Delaware Public Service Commission at the following address within thirty (30) days after publication of this notice.
