On December 19, 2025, Tidewater Utilities, Inc., filed an application with the Delaware Public Service Commission ("PSC") for a Certificate of Public Convenience and Necessity ("CPCN") to provide water services to the following parcels: (1) 2-00-07900-01-0100 is a parcel located on the east side of Bayside Dr and is located about 2500 feet from the intersection of Bayside Dr. and S. Little Creek Rd. (2) 5-00-16103-01-3400 is a parcel located on the east side of Yellow Wood Dr. and is located at the intersection of Yellow Wood Dr. and Aster Way. (3) 7-00-10400-01-4700 is a parcel located on the west side of Ponderosa Dr. and is located about 1300 feet from the intersection of Ponderosa Dr and Cypress Branch Rd. (4) 8-00-12212-01-1500 is a parcel located on the east side of E Poplar St. and is located about 96 feet from the intersection of E Poplar St and E 2nd St. (5) 8-00-12300-01-1200 is a Parcel located on the south side of Bowers Beach Rd. and is located about 1570 feet from intersection of Bowers Beach Rd. and Whitwells Delight Rd. The basis for the application is Tidewater Utilities, Inc. possession of petition requesting water services signed by all of the landowners in the proposed service area as set forth in 26 Del. C. §203C(e)(1)b.

The PSC is investigating this matter to the extent deemed necessary to determine whether the CPCN should be granted. An evidentiary hearing on this application will not be held unless there is a meritorious request received within thirty (30) days of publication of this notice. A meritorious request is deemed to be one which sets forth reasonable grounds why a public hearing would be appropriate or would be in the public interest.

Pursuant to current law, property owners within the proposed CPCN service area may file an objection to the issuance of a CPCN to Tidewater Utilities, Inc. and may also choose to "opt-out" of inclusion in the proposed service area. Written notice of such objection or a decision to "opt-out" of inclusion in the proposed service area must be sent to the Delaware Public Service Commission at the following address within thirty (30) days after publication of this notice.
