On March 11, 2026, Tidewater Utilities, Inc., filed an application with the Delaware Public Service Commission ("PSC") for a Certificate of Public Convenience and Necessity ("CPCN") to provide water services to the following parcels: (1) 8-00-11204-01-2200- is a parcel located on the north side of Irish Hill Rd. and is located about 442 feet from the intersection of Irish Hill Rd. and Dogwood Dr. (2) 8-00-12103-02-0700- is a parcel located on the north side of Hudson Branch Dr. and is located about 663 feet from the intersection of Hudson Branch Dr and McGinnis Pond Rd. (3) 8-00-12212-01-5400- is a parcel located on the east side of Poplar St. and is located about 30 feet from the intersection of Poplar St. and E 4th St. (4) 8-00-13000-02-5100- is a parcel located on the north side of Midstate Rd. and is located about 410 feet from the intersection of Midstate Rd. and Spring Dale Ln. (5) 8-00-13000-02-5000- is a parcel located on the north side of Midstate Rd. and is located about 335 feet from the intersection of Midstate Rd. and Spring Dale Ln. (6) 8-00-13001-03-3700- is a parcel located on the west side of Lake Dr. and is located about 225 feet the intersection of Lake Dr. and Center Dr. (7) 8-00-13001-03-3600- is a parcel located on the west side of Lake Dr. and is located about 350 feet the intersection of Lake Dr. and Center Dr.

The basis for the application is Tidewater Utilities, Inc. possession of petition requesting water services signed by all of the landowners in the proposed service area as set forth in 26 Del. C. §203C(e)(1)b.

The PSC is investigating this matter to the extent deemed necessary to determine whether the CPCN should be granted. An evidentiary hearing on this application will not be held unless there is a meritorious request received within thirty (30) days of publication of this notice. A meritorious request is deemed to be one which sets forth reasonable grounds why a public hearing would be appropriate or would be in the public interest.

Pursuant to current law, property owners within the proposed CPCN service area may file an objection to the issuance of a CPCN to Tidewater Utilities, Inc. and may also choose to "opt-out" of inclusion in the proposed service area. Written notice of such objection or a decision to "opt-out" of inclusion in the proposed service area must be sent to the Delaware Public Service Commission at the following address within thirty (30) days after publication of this notice.
