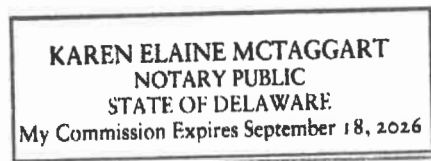

On June 12, 2026, Tidewater Utilities, Inc., filed an application with the Delaware Public Service Commission ("PSC") for a Certificate of Public Convenience and Necessity ("CPCN") to provide water services to the following parcels: (1) 2-00-07500-02-2901- is a parcel located on the east side of Rose Valley School Rd. and is located about 695 feet from the intersection of Rose Valley School Rd. and Yoder Dr. (2) 6-00-14700-01-1103 - is a parcel located on the west side of Black Swamp Rd. and is located about 5-465 feet from the intersection of Black Swamp Rd. and Burnite Mill Rd. (3) 6-00-15600-01-0601 - is a parcel located on the north side of Whiteleysburg Rd. and is located about 930 feet from the intersection of Whiteleysburg Rd. and Ingram Branch Rd. (4) 6-00-16700-01-1400 - is a parcel located on the south side of Whiteleysburg Rd. and is located about 1,440 feet from the intersection of Whiteleysburg Rd. and Ingram Branch Rd. (5) 6-00-15600-01-1600 - is a parcel located on the north side of Whiteleyburg Rd. and is located about 1,350 feet from the intersection of Whiteleysburg Rd. and Bullock Rd. (6) 7-00-10416-01-4500 - is a parcel located on the east side of Brookview Ave. and is located about 230 feet the intersection of Brookview Ave. and Brookdale Rd. The basis for the application is Tidewater Utilities, Inc. possession of petition requesting water services signed by all of the landowners in the proposed service area as set forth in 26 Del. C. §203C(e)(1)b.

The PSC is investigating this matter to the extent deemed necessary to determine whether the CPCN should be granted. An evidentiary hearing on this application will not be held unless there is a meritorious request received within thirty (30) days of publication of this notice. A meritorious request is deemed to be one which sets forth reasonable grounds why a public hearing would be appropriate or would be in the public interest.

Pursuant to current law, property owners within the proposed CPCN service area may file an objection to the issuance of a CPCN to Tidewater Utilities, Inc. and may also choose to “opt-out” of inclusion in the proposed service area. Written notice of such objection or a decision to “opt-out” of inclusion in the proposed service area must be sent to the Delaware Public Service Commission at the following address within thirty (30) days after publication of this notice.
