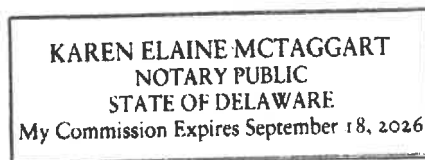

On June 12, 2026, Tidewater Utilities, Inc., filed an application with the Delaware Public Service Commission ("PSC") for a Certificate of Public Convenience and Necessity ("CPCN") to provide water services to the following parcels: (1) 6-00-16000-010100 - is a parcel located on the east side of Route 13 and is located about 2,815 feet from the intersection of Route 13 and Paradise Alley Rd. (2) 6-00-15600-01-0600 - is a parcel located on the north side of Whiteleysburg Rd. and is located about 3,915 feet from the intersection of Whiteleysburg Rd. and Burnite Mill Rd. (3) 6-00-14800-01-4500 - is a parcel located on the west side of Route 13 and is located about 2,415 feet from the intersection of Route 13 and Paradise Alley Rd. (4) 6-00-15900-01-3203 - is a parcel located on the west side of Route 13 and is located about 2,820 feet from the intersection of Route 13 and Paradise Alley Rd. (5) 6-00-15900-01-3204 - is a parcel located on the west side of Route 13 and is located about 3,010 feet from the intersection of Route 13 and Paradise Alley Rd. (6) 6-00-15900-01-3205 - is a parcel located on the west side of Route 13 and is located about 3,190 feet from the intersection of Route 13 and Hopkins Cemetery Rd. (7) 6-00-15900-01-3206 - is a parcel located on the west side of Route 13 and is located about 2,970 feet from the intersection of Route 13 and Hopkins Cemetery Rd. (8) 6-00-15900-01-3305 - is a parcel located on the north side of Hopkins Cemetery Rd. and is located at the intersection of Hopkins Cemetery Rd. and Raughley Rd.

The basis for the application is Tidewater Utilities, Inc. possession of petition requesting water services signed by all of the landowners in the proposed service area as set forth in 26 Del. C. §203C(e)(1)b.

The PSC is investigating this matter to the extent deemed necessary to determine whether the CPCN should be granted. An evidentiary hearing on this application will not be held unless there is a meritorious request received within thirty (30) days of publication of this notice. A meritorious request is deemed to be one which sets forth reasonable grounds why a public hearing would be appropriate or would be in the public interest.

Pursuant to current law, property owners within the proposed CPCN service area may file an objection to the issuance of a CPCN to Tidewater Utilities, Inc. and may also choose to “opt-out” of inclusion in the proposed service area. Written notice of such objection or a decision to “opt-out” of inclusion in the proposed service area must be sent to the Delaware Public Service Commission at the following address within thirty (30) days after publication of this notice.
