NOTICE OF PUBLIC EVIDENTIARY HEARING

**TO: ALL NATURAL GAS CUSTOMERS OF DELMARVA POWER & LIGHT

The Delaware Public Service Commission (“Commission”) will conduct a public evidentiary hearing concerning the above-captioned case (as further explained below) at the following time and location:

On August 28, 2025, Delmarva Power & Light Company (“Delmarva” or the “Company”) filed with the Delaware Public Service Commission (the “Commission”) an application (the “Application”) pursuant to 26 *Del. C.* §§ 303(b), 304, and 306 seeking to change its Gas Cost Rates (“GCR”) as follows:

For the average residential gas space heating customer using 56 ccf of gas per month, the proposed rates would result in an increase of approximately \$11.33, or 13%, on a typical monthly bill. During the winter months, a typical residential gas space heating customer using 78 ccf of gas per winter month would experience a monthly bill increase of approximately \$15.77, or 14%, per winter month.

By Order No. 10850, dated October 15, 2025, the Commission permitted the proposed GCR and other rates to become effective with usage on and after November 1, 2025, subject to refund and pending the Commission's final decision after evidentiary hearings and any other proceedings that may be necessary.

On April 22, 2026, the Commission issued Order No. 11003, permitting proposed changes to the GCR to become effective with usage on and after May 1, 2026, with proration and subject to refund pending the Commission's final decision after evidentiary hearings and any other proceedings that may be necessary, as follows:

For the average residential gas space heating customer using 15 ccf of gas per month, the proposed rates would result in an increase of approximately \$2.02, or 5%, on a typical monthly bill.

The Commission will conduct an evidentiary hearing on the Application on the date and at the time and location noticed above. The Commission's final decision will be based on the entire record of the case.

Only those persons or entities who are parties or were granted intervention in this docket will be allowed to present witnesses, conduct cross-examination, or introduce evidence at the evidentiary hearing. Members of the public are welcome to attend the evidentiary hearing as observers.

You may review Delmarva's Application, the non-confidential testimony and materials filed by Delmarva and other parties, and any other non-confidential materials subsequently filed in this matter.
